If you need to reserve a flight, please look at both the Detroit (DTW) and Toledo (TOL) airports. In most cases, flights from the Detroit airport are more cost effective, but sometimes the Toledo airport offers better rates. You will also need to rent a car or look into a car service to complete your journey to downtown Toledo. The DTW airport is 45 minutes, and the TOL airport is 25 minutes from the hotel.

USWCA Meeting Registration will be available beginning at 11:00am on Friday, September 14<sup>th</sup>. Committee meetings will begin on Friday afternoon. A President's Dinner, hosted by Bowling Green Curling Club, will be held a short distance from the hotel at the home of Ed and Mary Glowacki on Friday evening.
