The Board of Directors consist of five officers, nineteen standing committees (plus one advisory) and sixty-three representatives from the member clubs. Some individuals hold more than one vote, i.e. those who chair a standing committee and are also a club representative.

Two-thirds constitute a quorum of which 25% must be present. We exceeded these requirements for the Winter 2010 Meeting of the Board of Directors with 42 members present and 23 proxies.

Opening Remarks

Present Jennifer Stannard welcomed all attendees and introduced the officers and Parliamentarian, Carolyn MacLeod.

All Past Presidents in attendance were recognized: Joanna Owens, Peggy Rotton, Donna Purkey, Judy Maier, Anne Robertson, Janet Farr, Florence Springstead, Star Pfiffner, Linda Draper and Bonnie Dixon.

Guests were: Alice Sedgwick, Chris Casper, Bobbie Stoll, and Naida Leslie.

The President asked for a motion to dispense with the reading of the minutes from the Fall 2009 Meeting and to accept as written. The motion was made by Peggy Rotton, seconded by Shelley Dropkin.

Copies of all reports are attached at the end of the minutes of the Board of Directors unless otherwise noted.

Officers Reports

President's Report – Jennifer Stannard

Jennifer thanked everyone for their attendance at this meeting. She answered the following questions over the past year.

- Regarding the statement that the USWCA is the oldest national curling organization: We are the oldest current national curling organization and the GNCC is the first national curling body, although it is now a regional organization.
- A club can send an alternate to the meetings in place of their Rep or sending a proxy.
- Request that the 5& Under Open event require female Skips: The goal of the 5&under Open event is to encourage grassroots curling and provide an option in areas where women's events are currently untenable. Based on past committee and Board of Directors discussion a female is not required to skip at the USWCA 5&Under Open.
- Regarding ice quality & USWCA's value of such was questioned with regard to a four-sheet club. The USWCA is committed to quality ice.

- Jennifer attended the opening luncheon for the Friendship Tour in Milwaukee.
- Letter of congratulations was sent to the Us Women's Curling Team and Coach Wally Henry.

First Vice President's Report – Nancy Seitz

Nancy discussed the roles of the USWCA Reps, Area Liaisons and how they can increase communication and awareness to members.

Second Vice President's Report – Maureen Guay

Maureen reported the following dates for next year's USWCA sponsored bonspiels.

Sr. Women's National Bonspiel: December 1-5, 2010 at the Blackhawk Curling Club in Janesville, Wisconsin.

National Women's Bonspiel: February 9-13, 2011 at the Cleveland Skating Club in Shaker Heights, Ohio

Secretary's Report – Jill Owens – No Report

USWCA Directories have been sent out to those not attending the Fall 2009 meeting.

Revised Directory changes have also been distributed. Directory changes are attached.

Treasurer's Report – Jean Vorachek

- The Royal Caledonian Curling Club was contacted and our overseas subscription with them will be invoiced on a yearly basis.
- The general fund is not maintaining a 2-year reserve for operating funds. Another source of revenue must be identified.
- The Treasurer's report was presented and accepted. Motion made by Pippa Broadhurst to accept report, seconded by Shelley Dropkin. Motion Passed.
- The financial statement is attached.
- **Motion: To accept to file the May 1, 2009 to February 2, 2010 financial statement.**
Motion Passed.

Standing Committee Reports

All American – Gloria Martino

- Gloria reported that a sixth person on a team is considered a substitute and a sixth pin will not be awarded by the USWCA though a club can purchase one if they so chose.
- *Reminder:* Clubs shall individually decide whether or not to allow Jr. Girls to participate in the All American and may choose to have an age provision for this group. All participating Jr. girls must be current dues paying club members.
- Please submit forms at end of event with roster of participations. The deadline to get the names into the US Curling News is April 20th.

Area Liaisons – Nancy Seitz

- A job description of the Area Liaison was reviewed. Emphasizing the importance of accurate and up to date contact information for reps.
- Liaisons get only one vote as their club representative.

Budget – Jean Vorachek

Proposed budget was distributed at the Board of Directors meeting.

Highlights:

- Interest income is down.
- Looking toward donations to help off set deficit.
- The cost of mileage reimbursement was discussed and the new rate will be 14 cents per mile as allowed by the IRS for charitable organizations. The bylaws will be amended to allow 100% reimbursement of the new rate if it does not exceed the allowable reimbursement for airfare.
- **Motion: To accept the proposed budget for May 1, 2010 to April 30, 2011.**

Motion Passed.

Bylaws – Carolyn MacLeod

- The Bylaws Committee submitted the amendment for succession of officers. And to modify standing rules. (Motion Attached) Casey Kramer seconded. Motion passed
- Linda Draper questioned an alternate covering for a rep. As long as the alternate is verified by the club and notice is sent to the Secretary in advance of the meeting it is allowed and is noted in the *Rules & Regulations*.
- Motion regarding fiscal process of committees was read by Chair Carolyn MacLeod (Motion attached). Motion was 2nd by Anne Robertson. Motion passed.

The Bylaw Committee is proposing an amendment to project funding approval / reimbursement. This motion will be presented at the Fall 2011 meeting for voting. The wording will be sent out 30 days prior to meeting. (Proposed amendment attached)

Five Year & Under Committee – Elizabeth Abeltin – No written report available.

Six events were held this year. The committee is in the process of completing the schedule for next year. Guidelines and policies are being review. The Five Year & Under Bonspiels can be all women; open - any combination; or all one gender. Other items under consideration by the Committee:

- Participation by Juniors. Junior years do count towards 5&Under. Clubs are responsible for making decision on junior participation in this event at their club.
- Females need to be encouraged to skip and participate in 5&Under. “*Yes, they can do it*”

Junior Bonspiel Committee– Shelley Dropkin

Reviewed past year participation, see report.

Membership Committee – Judy Maier for Carol Wood

- Membership is down 156 from last year.
- There are two delinquent clubs. One is in the process of paying their dues.
- Hollywood, CA and Cape Coral, FL are two new clubs looking to join the USWCA.
- Bismarck Curling Club will be dropping out of the organization due to fewer members and lack of interest. They were offered an option of special waiver.

National Bonspiel Procedure Committee– Star Pfiffner

- Charlene Fitzgerald, On-site Chair, was present and passed out a Schedule of Events for the coming week. *Fire on Ice* is the theme for the 2011 National Bonspiel being held February 9-13, 2011 at the Cleveland Skating Club
- The committee is working on updating the National Bonspiel Procedural Manual. Five-person teams: five-member teams are not allowed and has been put down in writing in the Procedural Manual. Carol Stevenson and Star Pfiffner are working on wording, etc.
- Number of teams from a particular area: The committee will not change the rules on limiting the number of teams from one area as this is a National event.
- Substitutes: Specific info will be in the manual regarding subs. The current format is that subs first come from the home clubs, then singles from the area who signed up with the Good Faith entry, then other singles from other areas, and finally local area subs.
- The good faith entry fee will not be eliminated.

- The USWCA pin stock is adequate.

Promotions – Bridget Matzke

Junior Equipment Project:

- Ten clubs responded to Bridget's request concerning junior equipment.
- \$4000 worth of equipment was sent out.
- USWCA stickers were sent out to Reps to put on equipment
- \$16,541.61 worth of junior equipment has been sent out since start of the project.
- The Project is over for the time. Promotions will review at a later time to re-start

Merchandise:

- New clothing is available with the new logo - no minimum order required. The new clothing supplier has offered to do web site orders. A link will be on the USWCA web site and the supplier will start to handle all future orders on line after the September 2010 meeting.
- The 2010 pin is available.
- The creation of a calendar has been nixed due to the short life of a calendar and the large amount of work that would be needed to create one.

Public Relations – Lorraine Waybourn

- A letter from the USWCA President was submitted to be included in the 2010 Mixed Championship Program instead of an ad.
- The PR Committee is working on the concept of a basic training seminar to offer to USWCA members on how best to work with local media/newspapers. This will be presented at the 2010 Fall meeting.
- Please use old stock of USWCA letterhead and envelopes until completed. New logo template to use as letterhead will be on the web site. Chris Casper has the stock of USWCA letterhead and envelopes.
- Please submit items for the web site in pdf format rather than word document.
- PR is working hard and diligently to prepare the WREP sheets and it would be greatly appreciated if you could post it on the bulletin board at your club.
- PR is also creating Bulletin Board header and ice logos to be used by clubs
- PR published ten articles and two ads in the *US Curling News*

Reference Committee – Carla Casper – No Report

Nothing new – all reference materials are secure and safe.

Rules – Carol Stevenson

The Rules Committee continues to review issues and questions sent to them in the past. They continue their housekeeping with the various committees to standardize wording and practices.

Incoming Scot Tour – Linda Draper for Margie Knitter

- The roster has been received from Scotland.
- Curling club expectations have been reviewed and home-stay expectations have been developed. Information sheets will go out to the Area Coordinators which will be distributed to the participating clubs.
- Each club hosting a Scot team will be charged a \$30 per person fee to be paid by 12/1/2010. One check should be submitted to the USWCA.
- Area Coordinators will be in touch with each participating club to get a brief club biography and review menus, gifts and entertainment. The club biography is to be back to Margie Knitter by May 2010.

Incoming Senior Women's Friendship Tour – Barb Hamm

- Thanks to all clubs hosting tour and to Casey Kremer for daily updates on the web site.
- The Friendship Tour ran from November 3rd through November 14th, 2009 ending in Cleveland.
- The Canadian curlers were from the Providence of Manitoba and all over 50.
- The Curlers were treated to a wide number of experiences and excellent curling.
- There was an excess of funds at the end of the Tour. Funds will be returned to participants and to the USWCA treasury.

Senior Bonspiel Procedure Committee - Roberta Craine

- Any changes to the official draw (which is based on number of sheets) must be approved by the Senior Bonspiel Procedure Committee.
- There is a three-game guarantee; one game a day and that you will not be out before Saturday of the bonspiel Jean Vorachek gave closing report of the Senior Bonspiel held in Grand Forks, ND.
- Roberta read Nancy Wilhelm's report for the 2011 Senior Bonspiel to be held in Janesville, Wisconsin at the Blackhawk Curling Club. Their theme will be *Lights on Ice*.

Women's Curling Development Fund Committee – Anne Robertson

- The WCDF can help with funding for ice rental for USWCA sponsored 5&Under events.
- As of 2010 the balance of the fund is \$11,111.16.
- \$2,535 has been made since May 1st from sale of Chick pins.
- Casey Kremer donated \$500 winning prize from golf outing.
- There were two applications for funding – for travel assistance from one individual and a team. \$800 was given to the team as the individual was also a part of the team.

USWCA/USCA Liaison - Janet Farr

- There has been no USCA meeting since last USWCA meeting.
- USCA distributed a publicity packet to clubs for the 2010 Olympics.

- Club curling continues to be important to the USCA; but during the Olympic year USCA has been focusing on the Olympics
- Next USCA meeting is in the Fall 2010.

Ad Hoc Committee Reports

Future Planning - Florence Springstead

No formal report as the committee is newly formed and has not met. The Committee will look to the future of the USWCA. How women are involved in curling; in the USWCA; concerns about ourselves, families, and friends. How we can, as an organization, sustain bonspiels, raise funds, implement ideas to further USWCA organization; keep our clubs viable, and help our regions grow.

Incoming scot tour fundraising – Donna Purkey for Carla Casper

- Promotion has donated \$5000 to the Incoming Scot Tour Fund and will be paid out in two payments
- Fund Raising Opportunities
 - Diane Firari will donate a quilt to be raffled off each year.
 - Possible grant opportunities.
 - Letters requesting donations will go out to past tour members and past presidents.
 - Silent auction to be held at the Fall USWCA meeting.
 - Corporate donations?
 - Individuals to sponsor a Scot tour team?
- Consider making changes in the tour - two or three areas vs. the whole country; shorten to tour from three weeks to two.

Women's Circuit – Dorothy Roach

(Formerly known as The National Women's Curling Tour)

- Women's curling circuit purpose is to increase participation in women's bonspiels and increase exposure of the USWCA to their members.
- The Women's Circuit will start next season, thus finalizing details ASAP.
- The Committee is using the GNCC Men's Curling Tour as a guide. See report for details.
- Coordinators for the East, Wisconsin, and Midwest. Reps, please go back to your Club Boards and "push" the circuit. Talk to women curlers on the event and encourage them to participate.
- The aim of the Circuit is to reach out to the curlers that have been curling more than five years, but are not yet at a top competitive level.
- Guidelines will be ready by the end of this curling season.
- USWCA sponsored events cannot participate in the Circuit because of the lottery selection procedures.

- This is not a fundraiser. The benefit is for membership growth.
- The committee is also looking for sponsorships.

Web site – Casey Kremer – No written report available.

- Casey acknowledged Alice Sedgwick’s dedication to the USWCA in her work on the Promotions Committee.
- Casey thanked Nancy Wilhelm who worked on assembling the new web site and getting it up and running.
- The new web site went live in November - www.uswca.org
- Currently only 65 members have people signed up for the member only site. ***Please*** encourage your members to sign up. This is a password protected area.
- We can grow only with information and members signing up on the member only site.
- Reports from the Fall & Spring meeting will be filed under their respective Standing and Ad Hoc Committee sites. The reports should be submitted to the Secretary first and she will submit to the web site coordinator. Files should be saved in the .pdf format.

Meeting coordinator - Naida Leslie

No report for the meeting. Her notes and suggestions have been turned over to the incoming President. Fifty USWCA members participated in the Winter Meeting and sixty participated in the Fall 2009 meeting.

Old Business

- Bylaws will submit a motion at the Fall 2010 meeting to incorporate web site as a standing committee.
- USWCA received thanks for the support given to Molly Jenson’s daughter and granddaughter.

New Business

- Florence Setchell passed this year.
- There was discussion around the Bryant Gumbel segment on curling and the Plainfield Curling segment (Comedy Central). There was strong consensus that the Bryant Gumbel segment was a poor promotion. Who has the responsibility for the athletes? Our athletes and sport were not portrayed in a very favorable aspect. How do we want to portray our sport? Focus on ‘anyone can do it’ or that it is an Olympic sport requiring skill and athleticism? Jennifer will respond on behalf of the organization to the USCA. She encourages us as USCA dues paying members to contact the USCA regarding your concerns about the recent publicity if you feel strongly.

Ending remarks by President Jennifer Stannard: Special thanks to Naida Leslie; Bobbi Stoll and Donna Purkey. A big thank you goes out to Jean Vorachek in her role as USWCA Treasurer for the past four years.

USWCA Board Meeting – February 10, 2010

MOTION:

The Bylaws Committee moves that the proposed amendments to the USWCA Bylaws – Article V/Officers and the USWCA Standing Rules, as written in the call to the USWCA Board of Directors February Meeting, be accepted.

Article V – Officers/Section 3. Vice Presidents

(a) The First Vice-President shall perform the duties of the President in her **temporary** absence or inability to serve and so acting shall have all the rights and powers of the President. The First Vice-President shall be the President Designate.
In the event of a resignation or permanent inability of the President to perform her duties, refer to the USWCA Standing Rules.

(1) She shall be responsible for the education.....

(b) The Second Vice-President shall perform the duties of the First Vice-President in her **temporary absence or inability to serve and so acting shall have all the rights and powers of the First Vice-President.** The Second Vice-President shall be the First Vice-President Designate.

In the event of a resignation or permanent inability of the First-Vice President or the Second Vice- President to perform her duties, refer to the USWCA Standing Rules.

(1) She shall serve as a member of the Membership.....

Standing Rules

4. Alternates: Subsection (a) now becomes entire wording in Standing Rule 4/ Alternates. Subsection (b) has been deleted.

An appointed or elected female Alternate for a Club Representative may attend the Board of Directors meetings in an official capacity if she is registered with the Secretary before the called meeting. She has all the voting privileges as the named Club Representative.

5. Election Procedures for USWCA Officers: New Standing Rule

(a) The Bylaws list the official procedure in the temporary absence of the President, First Vice-President and Second Vice-President as well as in the temporary absence or permanent replacement of the USWCA/USCA Liaison. The permanent replacement of the President, First Vice-President and Second Vice-President is covered in below in Subsections (b), (c), (d) and (e).

(b) If the President resigns or is permanently unable to perform her duties after the Fall Meeting, the First Vice-President shall become Acting President and also continue her

duties as First Vice-President. If a resignation or permanent inability to perform occurs between May 1st and the Fall Meeting, first the Nominating Committee shall recommend that the out-going President remain in office for the upcoming term. If she declines, the Committee shall nominate an active Past President, from the same region as the resigning President, to serve out the term.

- (c) If the First Vice-President resigns or is permanently unable to perform her duties after the Fall Meeting, the Second Vice-President shall become Acting First Vice-President and also continue her duties as Second Vice-President. If a resignation or permanent inability to perform occurs between May 1st and the Fall Meeting, the Nominating Committee shall nominate a previously-eligible candidate, from the same region as the First Vice-President, to serve out the term.
- (d) If the Second Vice-President resigns or is permanently unable to perform her duties at any time during her term, the Nominating Committee shall nominate a previously-eligible candidate from the same region as the Second Vice-President to serve out the term.
- (e) The nominations/recommendations detailed in (b) (c) and (d) above originate with the Nominating Committee and are communicated in a timely manner to the Executive Council for a vote (via phone or email) with ratification of the vote by the Board of Directors occurring at their next regularly-scheduled meeting.

6. Election Procedure for USWCA/USCA Liaison: **(Renumbering of Rule - no changes)**
