Information needed to complete the form:

- Entry type (Single, Club Team or Composite Team)
- Your USWCA region
- Club name
- USWCA Club Representative's email
- For each team member:
  - Name, address, email address, and phone number
  - Position
  - Any food allergies
  - Club Rep name and email address
  - Whether or not this person has attended the National Bonspiel before
- If the team is a Composite Team, provide the Club name and Club Rep information for each team member. A Composite team has one or more members from different USWCA clubs.
- Team contact person
- Is the team willing to be on the waiting list if they are not selected? How long are you willing to stay together as a team?
- If the team does not stay on the waiting list, are any individuals willing to be substitutes?

**IMPORTANT:** Enter your club representative's email address carefully! Misspellings will delay your entry.

Using the above link, complete the form online. When the form is complete, click "Submit" and the form will be routed to your club rep for approval. All entries must be submitted and certified by the club representative before December 2, 2025 at the latest but individual clubs may have earlier deadlines if a playoff is necessary. It is important to note that by submitting the form, you agree that all players are over 21 years of age and are full dues-paying, league-playing members of a USWCA member curling club and if your team is selected, you will pay the \$560 entry fee, plus any applicable service fees, before December 17<sup>th</sup>.

Note: No payment is due at this time. Single entries do not owe an entry fee until they are assigned to a team.

Once your team is selected, there will be two options to pay the entry fee:

1. Use Zelle via your bank's online banking application for **NO FEE**

- a. Scan QR code below or access [ZellePay.com](https://ZellePay.com) to see if your financial institution participates in the Zelle network.
- b. Send fee to [uswca.treasurer@gmail.com](mailto:uswca.treasurer@gmail.com)
- c. In the memo line state: National Bonspiel Fee – Team Skip Name

OR

2. Contact the USWCA Treasurer to pay with either a credit or debit card
  - a. Email [uswca.treasurer@gmail.com](mailto:uswca.treasurer@gmail.com) and request to be invoiced for the bonspiel fee
  - b. Invoice will include a \$17.00 fee to cover the cost of a card payment

If you do not pay your bonspiel fee by December 10th, the Treasurer will automatically invoice you for the bonspiel and card fee.
