



SCOT TOUR AT LAST

Ever wondered why anticipating a celebrated event seems to make time slow down? Well, try waiting ten years and then add an extra year and nine months for the legendary Scot women to arrive for the USWCA Women's Scot Tour. It was indeed a long wait and well worth the time and planning to greet the Scottish women at the airport. So began a Tour spanning from MN, CO, WI, IL, OH, MI, ME, NH, and to MA. Every club, 13 total, and region brought a strong sense of camaraderie in gathering and curling... serving to build stronger friendships for this global sport. Every club the Scots visited could not believe the graciousness and kindness shared with a touch of the local culture. The Scot women truly enjoyed every city and club they visited.

The Skips and teams were named after the Lochs throughout Scotland: **Coruisk** (Skip Vicky Gumley), **Maree** (Skip Ann Gibb), **Etive** (Skip Janine Wilson), **Ness** (Skip Fiona McLaren), and **Katrine** (Skip Anne Shaw). On the Tour, these worthy opponents visited clubs in nine states for a total of 21 roaring games ... and came away victorious scoring 719 stones to the US 536. The USWCA women may have lost in scoring, but certainly gained lasting friendships with invitations to visit Scotland and most Scots plan to return to the US for a visit. ...Continued on page 3

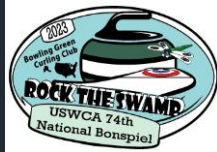
SENIOR WOMEN'S BONSPIEL

SENIOR FRIENDSHIP TOUR TO CANADA IN 2024

Curling Canada has extended an invitation to the USWCA to host 16 US curlers for the 2024 Senior Women's Friendship Tour to the Ontario and Quebec provinces. Tentative dates for the tour are Nov. 3-14, 2024. The Tour is anticipated to be 12 days in length including travel to and from Canada. No budget has yet been set but past tours have run approximately, to \$1500-\$2000 per participant, excluding airfare.

Applicants must be age 50 by May 1, 2024. Stick curlers are welcome. The online application will be available on the USWCA website beginning on September 15, 2023. The deadline to apply is December 15, 2023. There is no limit on the number of applications that can be submitted by USWCA members of a particular club. Past participants of outgoing Friendship or Scot Tours are ineligible. Note that applicants will need submit two letters of recommendation, one from their current Club president or other Club officer and one from their USWCA Representative. Names will be selected by lottery early in 2024.

The USWCA (your curling association) may seem to be a remote thing to the average club curler. Maybe you haven't curled in the marquee USWCA events: Super Senior, Senior Women's, 5 and Under, National Women's. Maybe you haven't signed up for Circuit events because you don't bonspiel often. I get it, work, children, elders...some seasons, life is busy.

The All-American is accessible. It should be on the calendar at every USWCA member club. Whether it is scheduled as part of your women's league, or as at my club, a stand-alone women's in-house weekend bonspiel event. A weekend of good curling, good food, a few good laughs and the sorority of women. As USWCA Rep I was happy to continue this tradition in my club. I hope every USWCA member club, and every Rep finds their own path to celebrate the USWCA and women's curling by hosting an All-American event annually.

5 & UNDER BONSPIELS

The Five and Under Bonspiel Committee sponsored five Events across the USA in the 2022-2023 season. The USWCA provides the event pins and promotes the events across the USA. Looking forward to the coming year, we will be surveying our women members who are 5 and Under curlers. We are talking with the host clubs of 5 and Under Women's events about scheduling 1- or 2-day 'spiels that might be a better fit for busy women curlers.

The survey will be sent to all the club Reps in March. When they receive it, we ask that they distribute the survey or provide our committee with a contact list (email) of your 5 and Under women members. The contact list can be sent to Dawn Brauningner at dawnakahm@yahoo.com. All emailed surveys will be sent as a "bcc with no attachments". Although this survey is voluntary the more participation we have will help us to provide a format that will help meet the needs of 5 and Under Women curlers.

In another change for the coming year, the minimum age for all USWCA 5 & Under Bonspiels (both our Open and Women's bonspiels) will be 21 to participate. Specifically, you must be 21 by the first day of the 5 and Under event. This is due to the age limit for the USA Curling 5 and Under National Bonspiel.

JUNIOR BONSPIELS

The Junior Bonspiel Committee sponsors three USWCA Junior Bonspiels annually across the country: one in the East, one in the combined Central & Wisconsin regions, and one in the West. As an event sponsor the USWCA provides winner and runner-up pins for four events, an inscribed plaque for the first event winners and advertisement of the bonspiel on the USWCA website. Travel assistance funds and funds for host clubs with arena ice are available through the Gifts and Grants Committee. See the article on page 7 for more information. Clubs that are hosting a USWCA-sponsored junior bonspiel must be a member of the USWCA. Bonspiel participants do not have to belong to a USWCA member club. The Junior bonspiels are open to teams of juniors under the age of 21.

USWCA ADOPTS CODE OF CONDUCT

In September 2022, the Board of Directors unanimously approved a Code of Conduct:

In keeping with the United States Women's Curling Association (USWCA) mission and the Spirit of Curling, we acknowledge the importance of treating all individuals with respect and seek to ensure that our membership is courteous and gracious in our discussions and operations as an organization, as well as during USWCA-sponsored events.

Note: This includes Circuit events but only off-ice problems that may occur between USWCA members and not problems directly associated with the bonspiel/games.

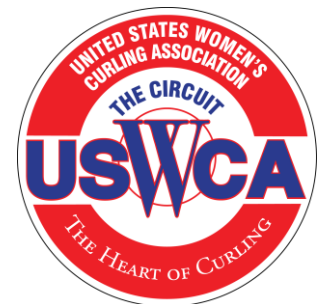
Cost:

Many women tell us that they forget to sign up for the Circuit before their first game (necessary for the bonspiel points to count) so we are adding NEW FEATURES:

- You can still enroll on-line at <https://www.uswca.org/circuit-individual-application>, but this Summer we will roll out a QR code at Circuit Bonspiels so that you can sign up through your phone or PC before your first game.
- New reports will simplify the 'admin' functions by reporting to the Circuit team so we can share 'stats' throughout the season via the USWCA website and Facebook.

Note: ALL FUNDS COLLECTED go back as prize money to the Circuit Curlers (per region).
A maximum of your top 3 events will count toward points.
80% of participants receive prize \$\$
